Minimum age requirement is twelve (12) years and requires a permission slip to be signed by parent or guardian before the start of class. (see below)

Upon successful course completion you will be awarded an NMLRA shooters card which qualifies you to compete in Royal Ranger and NMLRA/NRA black powder rifle competition events.
